Preface

This volume consists of 12 papers by invited speakers of the International Conference “Model Theory of Modules, Algebras and Categories”, held at the *Ettore Majorana Foundation and Centre for Scientific Culture* in Erice, Italy, July 28–August 2, 2017. The meeting had 38 participants and was dedicated to Mike Prest of The University of Manchester on the occasion of his 65th birthday. The focus of the articles is on recent developments in the model theory of modules, as well as the broad influence, sometimes explicit, sometimes implicit, that the model theory of modules has had on the representation theory of algebras and certain regions of category theory. For over three decades now, the model theory of modules has developed under the auspices of Mike Prest and his school. The interdisciplinary nature of his work is reflected in this volume, with articles ranging from the following broad topics:

- Logic, notably model theory of modules and groups.
- Representation theory (pure-injective and pure-projective modules and their generalizations, silting theory).
- Category theory and homological algebra (derived categories, localizations, recollements).

The meeting was marked by the unexpected death of Gena Puninski in spring 2017. Gena was a leading figure in the model theory of modules and a collaborator and friend of many of the participants. On the second day of the conference a memorial session was held in honour of Gena.

We thank the speakers and participants who made the conference a success, all authors for their contributions and the referees for their time, careful reading and suggestions for improvement.
